

## SEC RULE 607 ORDER DISCLOSURE

The U.S. Securities and Exchange's Rule 607 ("**Rule 607**") requires broker-dealers, such as Lime Trading Corp. ("**Lime Trading**"), to disclose its payment for order flow practices. Lime Trading receives compensation for directing customer orders to certain broker-dealers or market centers for execution. The details of these payments are available upon written request.
